Administrative Order

The Presiding Judge of the Superior Court in Mohave County, Arizona, finds as follows:

1. That ARS: 8-237 authorizes the Superior Court to establish a public council or committee having as its object the prevention of juvenile delinquency and may cooperate with, or participate in, the work of any such council or committee for the purposes of preventing or decreasing juvenile delinquency, including the improving of recreational, health, and other conditions in the community affecting juvenile welfare.
2. That the Chief Justice of the Arizona Supreme Court has requested that the Superior Court in all the counties enlist community involvement and support in addressing issues related to juvenile crime.
3. That there is interest in soliciting community involvement in adult community corrections issues.
4. That on May 15, 1995, the Mohave County Superior Court Citizens Advisory Board (CAB) was established to create a forum for two-way communication and problem solving between the Superior Court and the community in regard to significant issues affecting the Juvenile Court and the probation department. The Citizens Advisory Board shall perform the following functions and responsibilities:
 - The CAB shall act as an advisory board making recommendations on ways the Mohave County Probation Department can continuously improve its services.
 - The CAB shall identify what the community wants from the Mohave County Probation Department .
 - The CAB shall evaluate what the community receives from the Mohave County Probation Department.

- The CAB shall make recommendations on what the community should be getting from the Mohave County Probation Department.
 - The CAB shall act as a sounding board for new ideas from the community and the Mohave County Probation Department.
 - The CAB shall assist in the development of increased public understanding and support for the Mohave County Probation Department .
 - The CAB shall recommend legislative changes to the Presiding Judge of the Superior Court as appropriate.
5. That the Mohave County Board of Supervisors has requested that the Probation Department administer the *Juvenile Accountability Incentive Block Grant* which requires that a *Juvenile Crime Enforcement Coalition (JCEC)*, composed of citizens and representatives of various agencies, be established.
 6. That the Mohave County Superior Court determines that, in the interest of efficiency, the CAB will carry out the functions and responsibilities of the JCEC.

The forgoing findings having been considered,

IT IS ORDERED that the structure, responsibilities, rules and bylaws of the Mohave County Superior Court Citizens Advisory Board (CAB) remain in effect.

IT IS FURTHER ORDERED that the functions and responsibilities of the JCEC relative to the *Juvenile Accountability Incentive Block Grant* shall be carried out by the CAB.

IT IS FURTHER ORDERED that the CAB shall act in an advisory capacity only and shall have no authority to direct or control the Presiding Superior Court Judge, other Judges, the Director of Juvenile Court Services, Chief Probation Officer or staff in any manner, nor control the administration of programs or to set policy.

IT IS FURTHER ORDERED that the Board shall consist of no less than 6 and no more than 12 members appointed by the Presiding Judge and shall conduct business in accordance with bylaws adopted by the Board and approved by the Presiding Judge.

IT IS FURTHER ORDERED re-appointing the following persons as members of the Mohave County Superior Court Community Advisory Board as of March 1, 2000 for the following terms :

Ms. Lois Wakimoto	3 year term
Dr. Dan Wynkoop	2 year term
Ms. Joan McCall	2 year term

Mr. Charles Casey 3 year term
Mr. Mr. Mike File 2 year term

IT IS FURTHER ORDERED appointing the following person as a new member of the CAB:


